3. <u>Incident Reporting Process:</u> Steve presented a draft of an Incident Report Form ("Form"). We should expand our incident response beyond gathering physical harm information referenced in the Insurance Incident Report ("Report") (such Report remains necessary should a Club member need to file a claim as under the Club's excess insurance policy (it is "excess" to any other available coverage, e.g. one's personal medical coverage or state no-fault coverage if a motor vehicle is involved)). Discussion among Board members provided suggestions for edits. An updated version of the form will be an agenda item at the next Board meeting for discussion and its ultimate adoption.

4. Election Logistics:

- Election Process: Sheila presented a targeted website update.
 - One of the components in our new website is the election process. We can have the election process coded into our new website or use an external election platform. The benefit of using an external platform is we neither need build the functionality nor do we need to maintain/update our website for this functionality (lower cost). I suggest 'Election Runner' and propose we use it for this year's election. The cost is \$300/year. It is simple to rollout: upload candidates and upload members. For further simplification, once the election ballot has been drafted it can be used going forward. The Board will go through a dummy election process for evaluation. Election Runner will be on the agenda at the next Board Meeting for Board approval.
